## Feast of the Month: St. Claude de la Colombiere

The Story of St. Claude de la Colombiere

## "O Sacred Heart of Jesus, I place all my trust in You."

Nearly every Catholic is familiar with these words and the devotion to the Sacred Heart of Jesus that came about as a result of a vision of Jesus in which He exposed His Sacred human heart, aflame with love for us, to St. Margaret Mary Alacoque. On the other hand, few persons know of her spiritual director, St. Claude de la Colombiere, who was responsible for making that vision known.

St. Claude was a Jesuit priest from France who came to know St. Margaret Mary by way of his appointment as rector to the Jesuit Community at Paray-le-Monial, including the church next to the monastery of the Nuns of the Visitation, her order. St. Margaret Mary had suffered greatly from persecution due to her sisters' unbelief of her ongoing private revelations. She opened up her heart to St. Claude, who listened to her story a number of times.



Then after much prayer he was convinced of their validity and became not only her supporter but a champion and apostle of the devotion to the Sacred Heart of Jesus for the rest of his life.

While on assignment in England, he was falsely accused and thrown into prison. When he was finally released, his health had taken a turn for the worse. He returned to France to die. He was beatified by Pope Pius XI and canonized by Pope John Paul II, who said that St. Claude's promotion of devotion to the Sacred Heart provided "spiritual strengthening for Christian communities so often faced with increasing unbelief."

St. Claude taught boundless

trust in the mercy of God. He wrote this prayer: Lord, if I have grievously offended You, My Redeemer, let me not offend You even more by thinking that You are not kind enough to pardon Me. Amen.

This dear Saint is the patron of toy makers and his feast day is February 15.

#### **Prayer and Action**

- Create a colorful banner or a prayer card with a large Sacred Heart of Jesus and the words, "Jesus I trust in You" on it and hang it somewhere that you will see it daily.
- Light a candle at church as a prayer for a loved one who has great doubts about God's love for them.
- Go to confession with a renewed trust in the mercy of God and offer your penance joyfully, remembering that your sins actually no longer exist.
- Ask St. Claude to pray for you to be able to abandon a specific worry you have to the Sacred Heart of Jesus.

## Pope names organizing committee for abuse conference in February

VATICAN CITY — Pope Francis named U.S. Cardinal Blase Cupich of Chicago to be part of the organizing committee preparing for a meeting of the world's bishops' conferences, and representatives of religious orders to address the abuse and protection of minors.

The Feb. 21-24 Vatican meeting is not only "about keeping children safe from harm worldwide," said Greg Burke, head of the Vatican press office, in a written statement Nov. 23.

"Pope Francis wants church leaders to have a full understanding of the devastating impact that clerical sexual abuse has on victims," he said, soon after the Vatican announced the members of the preparatory committee.

Together with Cupich, the committee will include Cardinal Oswald Gracias of Mumbai, India; Archbishop Charles Scicluna of Malta; and Jesuit Fr. Hans Zollner, president of the Centre for the Protection of Minors at the Pontifical Gregorian University and a member of the Pontifical Commission for the Protection of Minors.

The Pontifical Commission for the Protection of Minors, headed by Boston Cardinal Sean O'Malley, and some survivors of abuse by members of the clergy also will be involved in the preparatory work for the meeting, the Vatican said.

"This a critical moment for the universal church in addressing the sexual abuse crisis," O'Malley said, and the February meeting "will be an important moment for developing a clear path forward

for dioceses around the world."

"We must continue to embrace and practice a commitment to zero tolerance, work for greater transparency, including the release of names of clergy accused of abuse, and encourage all religious orders to adopt a similar policy and cooperate with civil and legal authorities. Above all else, we must place the support and pastoral care of survivors first," he said in a written statement Nov. 23.

"This is a lifelong journey" that "requires a partnership between the laity and clergy in responding to the failures of episcopal leadership by holding bishops accountable for the crimes against children and vulnerable adults," he said.

O'Malley said the pontifical commission, as an advisory body to the pope, proposed the global meeting for the world's bishops. He said the commission has hosted meetings between survivors and groups of newly named bishops, and those meetings "have inspired our view that calling the bishops to Rome for a similar high-impact meeting would be very important in addressing the clergy abuse crisis globally."

Cupich told Crux Nov. 23 that while Francis understands very well the degree of suffering in the United States because of abuse, the pope is calling a global meeting because "he understands this to be a global issue."

"The pope is seeking both a comprehensive understanding of past failings, as well as global solutions moving forward," the cardinal said Nov. 23.

Cupich told Crux it will be critical that all church leaders take "ownership for our failures fully in order to ensure they are not repeated." This will require clearly defining responsibilities and establishing "responsiveness, transparency, and accountability, particularly for bishops," he added.

He said the pope sees safeguarding as part of his call for a change of culture, "that is, a reform in how we approach ministry for, in addition to being a crime, sexual abuse of minors by clerics is about the corruption of our ministry."

The February meeting "is the beginning of a worldwide reform that will need to be ongoing

and will involve a process of initiatives on regional, national and diocesan levels," he said.

Gracias told Crux in October that the February meeting "cannot be cosmetic" or superficial. "Either it will be successful, or it will be a disaster for the church."

The other organizing committee member is Scicluna, who has assisted the pope with several high-profile abuse investigation cases. He serves as adjunct secretary of the Congregation for the Doctrine of the Faith and is president of the congregation's board that reviews appeals filed by priests laicized or otherwise disciplined in sexual abuse or other serious cases.

Scicluna said the meeting will include "a penitential liturgy" because "Pope Francis wants it." He said abuse survivors "are going to be a part of that liturgy too, just as they will be consulted in advance of the meeting and be listened to during it."

The meeting will mark "the beginning of a new approach that I hope will be global, because it concerns the whole church," he said. However, all solutions and approaches will have to be lived concretely on the local level, "in every parish, in every school, in every diocese," he said, "otherwise it's not effective at all."

"We have to move away from panic-driven policies that put the good name of the institution above all other considerations."

Zollner, who is also a licensed psychologist and psychotherapist and has accompanied abuse survivors to the Vatican, said the pope will be present at the February meeting's work sessions. Those who are invited to the meeting include presidents of national bishops' conferences around the world; heads of the Eastern Catholic churches; representatives of the Union of Superiors General and of the International Union of Superiors General; top officials of the Secretariat of State; prefects of the congregations for the Doctrine of the Faith, for Eastern Churches, for Bishops, for the Evangelization of Peoples, for the Clergy, for Institutes of Consecrated Life and Societies of Apostolic Life, and of the Dicastery for Laity, the Family and Life.

## Rite of betrothal / Do miscarried children go to heaven?

**Q.** I have heard that the "rite of betrothal" is becoming popular in certain young Catholic circles. What does this rite entail? Was it more common prior to the Second Vatican Council? Would you recommend that an engaged couple seek out this rite? (Washington)

A. The rite of betrothal was a little-known but long-standing service of prayer in which a couple had their engagement formally blessed by a priest. The 1906 edition of The Catholic Encyclopedia notes that the ritual was more common in other countries than in the United States. An English version is still available, as an addition to Father Philip Weller's translation of the 1962 Roman Ritual (although the rite did not form part of that ritual itself.)

There is no prohibition against using that rite today, although it has largely been replaced in the contemporary church by the Blessing of an

Engaged Couple from the church's Book of Blessings, published in 1989. That newer rite celebrates in prayer a newly engaged couple and asks the Lord to guide them as they prepare for marriage; it can be celebrated by a priest, deacon or lay minister, and includes scriptural reading

The engagement rings may be blessed during the ceremony, and the celebrant prays:

"Lord God, the source of all love, the wise plan of your providence has brought these young people together. As they prepare themselves for the sacrament of marriage and pray for your grace, grant that, strengthened by your blessing, they may grow in respect for one another and cherish each other with a sincere love."

I would recommend that a couple use this newer blessing.

Q. I know that life begins at conception. So I want to believe that when a woman has a miscarriage, no matter how early in the pregnancy, her unborn baby goes to heaven -- but I am wondering what the church's view is on this. (As a woman who has experienced a miscarriage, I would find great comfort in knowing that I

will be reunited someday with my baby in heaven.) (Pennsylvania)

**A.** I suppose that a theological purist might say that there is no definitive church position on the ultimate fate of a miscarried child.

But from many things that the church has, in fact, taught in its official documents, it seems reasonable to assume that the child is in heaven. The Catechism of the Catholic Church says, "Baptism is necessary for salvation for those to whom the Gospel has been proclaimed and who have had the possibility of asking


for this sacrament" (No. 1257).

But the miscarried child has had, of course, no chance to ask for the sacrament. The catechism later says, "Indeed, the great mercy of God who desires that all men should be saved, and Jesus' tenderness toward children which caused him to say: 'Let the children come to me, do not hinder them,' allow us to hope that there is a way of salvation for children who have died without baptism' (No. 1261).

When an infant is baptized, the infant makes no personal profession of faith; instead it is left to the parents and godparents to voice their desire to have the child christened. Why wouldn't the same logic prevail in the case of a miscarriage? Had the child been carried to term, the parents would certainly have had the child baptized, so why wouldn't a merciful God who reads hearts consider that intention sufficient?

Be comforted and at peace: I think it's quite likely that you will meet your child in heaven.

So here is this month's question: "I am a baptized Catholic, but divorced and remarried outside of the Catholic Church. I want to reengage in my faith and have my marriage blessed. Is that possible? If so, where do I begin?"

If the National average of divorces in the United States is correct, this question is likely a common one with our readers (either from personal experience or with family and friends). As mentioned above, each situation is different and there really is no

absolute answer that will apply across the board, except for the answer..."It depends."

Our Catholic Church teaches that a wedding (and subsequent marriage) is indeed sacred and its sanctity must be protected at all costs. With that said however, there are instances where an impediment or serious defect of consent may have existed on the day of the wedding. If the impediment is proven, it may be grounds to declare that, though the vows may have been exchanged, there was no true intention to fulfill them by one or both parties. The familiar term for the process of proving this is getting your wedding "annulled". It is unfortunate that the stigma associated with going through an annulment brings much fear and stress to those facing the process. I suppose knowing you may have to recall some of the difficulty in your past can be unpleasant and overwhelming, but it can also be a time for healing and bringing closure to that part of your life. Please do not let the anxiety of the unknown regarding the process keep you from moving forward.

So, where do you begin?? My suggestion is to start with speaking with your pastor. Tell him about your specific situation and ask for guidance. He will be able to provide spiritual support and direct you to the resources that will help. Another valuable resource is the Diocese of Alexandria's Tribunal Office. They are the experts and are dedicated to assisting you in the annulment process. To see their information (including an outline of the process and/or to begin the online application) visit our website at: www.Diocesealex. org, look for the tab "Our Diocese", and then "Tribunal/ Marriage Annulments".

The only way you will know the answer to your specific situation is to ask the question.

So if this topic applies to you or a loved one, I encourage you to take the steps to find out more information. If you do, and you are able to come into full communion with the Church, I know you will come to have a better appreciation for the sacrament of matrimony and will Love the Liturgy.



## Diocese releases names of Clergy credibly accused

## Letter to the Faithful of the Diocese of Alexandria

February 6, 2019

Like many of you, I was horrified and scandalized to read the results of the Pennsylvania Grand Jury report published in the summer of 2018 detailing the history of sexual abuse perpetrated by Catholic clergy against minors over so many decades. In the 1980s, the public prosecution of Fr. Gilbert Gauthe of the Diocese of Lafayette shined a light into the darkness of this evil in the life of the Church.

Since the adoption of the United States Conference of Catholic Bishops' Charter for the Protection of Children and Young People in 2002, the 'Dallas Charter', our diocese has urged victims of clergy sexual abuse of minors to come forward and many have. In the last sixteen years our Diocesan Permanent Review Board, composed of both laity and clergy, has reviewed all allegations made against clerics, diocesan and religious, and laity, living and deceased. Counseling and pastoral care have been offered to all who have come forward and in some cases, financial settlements were made.

As Bishop of Alexandria, I have promised to do everything in my power to safeguard our children and youth and to help those abused in the past. To aid in the healing process, in August of 2018, I ordered an examination of all our files dating back to the establishment of the Diocese of Natchitoches in 1853. A system of examination was established by which every file held by our Diocese of Alexandria would be reviewed by two sets of examiners: one comprised of the chancellor and vice-chancellor and one comprised of laity from our Permanent Review Board and other lay readers appointed by me.

To insure the most thorough process of examination in these cases, a special ad-hoc committee of the Review Board was established to review all the case histories of the Review Board from its inception up to the present day, along with all the information gleaned from the file review. This

was done with a view to publish a list of the names of those clergy (bishops, priests and deacons), living and deceased, who we believe could be credibly accused of sexual abuse of minors.

In publishing this list, it is not our intent to re-victimize those who have already been so wounded by the actions of some clerics who served in our diocese over the past one hundred sixty-five years. This evil can only be purged through a vigilant process that is transparent to the public. Our response must demonstrate the highest levels of honesty and scrutiny.

I believe, together with all the members of the Permanent Review Board, that we have done what we can to present as truthful and as thorough a record of the alleged instances of sexual abuse by clerics against minors during our long history. I know that this list may be incomplete, not because we have held anything back, but because this kind of evil is perpetrated in secret and out of fear and shame some may not have been able to come forward.

The names that are published below are those of clergy, diocesan and religious, living and deceased, whom the Permanent Review Board unanimously believes have been or could be credibly accused of sexual abuse of a minor. If any allegation is made against a living cleric, national and diocesan protocols, in place since 2002, become applicable. When this occurs, the police are notified and our Victims' Assistance Coordinator begins his service to the victim while an assessor begins an investigation for the Permanent Review Board.

Some of the names below are of living clerics. Such cases have been brought forward for review according to national and diocesan protocols and procedures. However, the great majority of the names listed below are of clergy who were deceased at the time allegations were made or their files were reviewed. On examination, in regard to these deceased clerics, enough written

evidence was reviewed case by case to believe that accusations against them are, in all likelihood, credible.

While this process of review and publication is not a declaration of guilt, it is our best assessment of all the evidence available to us at this time. We believe that publically listing these names is a matter of justice if we are to help the victims and the Church we love and serve. It is our continued hope that anyone who has been abused will come forward to speak the truth and seek the healing that all decire.

If you are a victim of sexual abuse, please contact your local law enforcement agency. Sexual abuse is a serious crime and must be treated as such. If you would like more information or are in need of assistance, please contact our Victims' Assistance Coordinator, Dr. Lee Kneipp, at (318) 542-9805.

Along with the need for justice, we must, at the same time, seek the healing grace that can come only from Our Savior who has ransomed us from the darkness of sin and death. Remembering Christ, Who is our Light, I ask all of us to continue to be vigilant in our efforts to safeguard our children and youth.

#### Names of Clergy accused

The following names are those of clergy duly incardinated or at one time serving in the Diocese of Alexandria accused of sexual misconduct and abuse of minors by allegations brought by victims or by written testimony:

#### A: Diocesan Clergy - Living

#### Fr. Frederick Lyons

- Multiple allegations of sexual misconduct and abuse of male minors dating back to the 1960s were brought before the Permanent Review Board in 2005 and 2006.
- Fr. Lyons was removed from active ministry in 2006.
- The allegations were deemed credible.
- After completion of the

investigation, Fr. Lyons' case was referred to the Congregation for the Doctrine of the Faith in Rome and ecclesiastical penalties were imposed in 2013.

#### Deacon Raymond M. Jones

- Review of Deacon Raymond Jones' file in 2019 showed evidence of sexual misconduct and abuse of a male minor dating from 1982.
- Deacon Jones was suspended from active ministry when the allegation was made known in 1986.
- His scheduled ordination to the priesthood was cancelled in light of the evidence and he was encouraged to seek laicization by Bishop Friend.
- He subsequently left the diocese.
- The evidence was presented to the Permanent Review Board in 2019 and the allegation was deemed credible.

#### **Donald Rogers**

- An allegation of sexual misconduct and abuse of a male minor dating back to 1962 was brought before the Permanent Review Board in 2004.
- Fr. Rogers was removed from active ministry in 1967.
- Fr. Rogers was laicized in 1974.
- Review of Fr. Rogers' file in 2019 showed evidence of multiple allegations of sexual misconduct and abuse of minors.
- The evidence was presented to the Permanent Review Board in 2019 and the allegations were deemed credible.
- Fr. Rogers was born in 1930 and would be 88 at the time of this letter. His whereabouts are unknown.

#### Fr. Victor Sepsi

- Review of Fr. Sepsi's file in 2019 showed evidence of multiple allegations of sexual misconduct and abuse of male minors dating back to the 1960s.
- Fr. Sepsi left the diocese and active ministry in 1967.
- The evidence was presented to the Permanent Review Board in 2019 and the allegations were deemed credible.
- Fr. Sepsi was born in 1930 and would be 88 at the time of this letter. His whereabouts are unknown.

#### **B:** Diocesan Clergy – Deceased

#### Fr. Edward Terry Allen

- An allegation of sexual misconduct and abuse of a male minor dating back to 1973 was brought before the Permanent Review Board in 2005.
- The accusation was deemed credible.
- Fr. Allen resigned from active ministry in 2005.
- A settlement was made with the victim in 2012.
- Fr. Allen died in 2018.

#### **John Wesley Andries**

- Multiple allegations of sexual misconduct and abuse of male minors dating back to the 2000s were brought before the Permanent Review Board in 2003 and Fr. Andries was removed from active ministry.
- The allegations were deemed credible.
- Civil charges were brought and Fr. Andries was convicted and sentenced.
- After completion of the investigation, Fr. Andries' case was referred to the Congregation for the Doctrine of the Faith in Rome and Fr. Andries was laicized in 2007.
- John Andries died in 2013.

#### Fr. William Allison

- An allegation of sexual misconduct and abuse of a male minor dating back to 1961 was brought before the Permanent Review Board in 2004.
- Fr. Allison died in 1986.
- Review of Fr. Allison's file in 2019 showed evidence corroborating the allegation.
- The evidence was presented to the Permanent Review Board in 2019 and the allegation were deemed credible.

#### Fr. William Cody Bressler

- Multiple allegations of sexual misconduct and abuse of male and female minors dating back to the 1960s were brought before the Permanent Review Board in 2004 and again in 2005 and were deemed credible
- Fr. Bressler died in 1990.
- Settlements were made with the victims in 2006 and 2017.
- Review of Fr. Bresslers' file in 2019 showed evidence

- corroborating the allegations.
- The evidence was presented to the Permanent Review Board in 2019 and the allegations were deemed credible.

#### Msgr. Paul Conway

- Allegations of sexual misconduct and abuse of female minors dating back to 1956 was brought before the Permanent Review Board in 2004 and after investigation the allegations were deemed credible.
- Msgr. Conway died 1996.
- Settlements were paid to the victims in 2005 and in 2017.

#### Fr. Francis O. Couvillion

- Review of Fr. Couvillion's file in 2019 revealed multiple allegations of sexual misconduct and abuse of male minors dating back to the 1950s.
- Fr. Couvillion died in 1978.
- The evidence was presented to the Permanent Review Board in 2019 and the allegations were deemed credible.

#### Fr. Francis Patrick Donohoe

- Former Capuchin incardinated in the Diocese of Alexandria by Bishop Desmond in 1942.
- Review of Fr. Donohoe's file in 2019 showed evidence of multiple allegations of sexual misconduct and abuse of male minors dating from the 1960s.
- · Bishop Greco asked for and received Fr. Donohoe's resignation as pastor and he was removed from active ministry in 1966.
- Fr. Donohoe died in 1983.
- This evidence was presented to the Permanent Review Board in 2019 and the allegations were deemed credible.

#### Fr. Harvey Fortier

- Review of Fr. Fortier's file in 2019 revealed an allegation of sexual misconduct and abuse of a male minor dating back to

- The allegation was deemed credible.
- A settlement was made with the victim in 1995.
- Fr. Fortier died in 1999.

#### Fr. Edmund Gagné

- Review of Fr. Gagné's file in 2019 showed evidence of multiple allegations of sexual misconduct and abuse of male minors dating back to the 1980s.
- Fr. Gagné was removed from public ministry in 1986.
- Fr. Gagné died in 1990.
- The evidence was presented to the Permanent Review Board in 2019 and the allegations were • deemed credible.

#### Fr. Moise Richard Gremillion

- Review of Fr. Gremillion's file in 2019 revealed multiple allegations of sexual misconduct and abuse of male minors dating from the 1960s.
- Fr. Gremillion retired from active ministry in 1969.
- Fr. Gremillion died in 1973.
- This evidence was presented to the Permanent Review Board in 2019 and the allegations were deemed credible.

#### Fr. Michael G. Hannon

- Review of Fr. Hannon's file in 2019 showed evidence of multiple allegations of sexual misconduct and abuse of male minors dating from the 1960s.
- Fr. Hannon left the diocese in
- Fr. Hannon was incardinated in the Diocese of Brooklyn in New York in 1982.

#### Fr. Kenneth Mathews

- The evidence was presented to the Permanent Review Board in 2019 and the allegations were deemed credible.

#### Msgr. H. Clinton Teacle

- Allegations of sexual misconduct and abuse of male minors dating back to the 1960s were brought before the Permanent Review Board in 2009.
- Msgr. Teacle died in 1969.
- Review of Msgr. Teacle's file in 2019 showed further evidence of sexual misconduct and abuse of male minors.
- The evidence was presented to the Permanent Review Board in 2019 and the allegations were deemed credible.

#### Joseph Tisch

- An allegation of sexual misconduct and abuse of a male minor dating back to 1967 was brought before the Permanent Review Board in 2014.
- Fr. Tisch left the diocese and active ministry in 1968.
- Joseph Tisch died in 2007 publically separated from the Church.
- Review of Fr Tisch's file in 2019 showed further evidence of sexual misconduct and abuse of male minors.
- The evidence was presented to the Permanent Review Board in 2019 and the allegations were deemed credible.

#### Fr. Léger Tremblay

- Allegations of sexual misconduct and abuse of male minors dating back to the 1950s and 1960s were brought before the Permanent Review Board in 2003 and again in 2005.
- Fr. Tremblay died in 2002.
- Settlements were made in 2004 and in 2005.
- Review of Fr. Tremblay's file in 2019 showed further evidence of sexual misconduct and abuse of male minors.
- The evidence was presented to the Permanent Review Board in 2019 and the allegations were

deemed credible.

#### Fr. Leo Van Hoorn

- An allegation of sexual misconduct and abuse of a male minor dating back to 1967 was brought before the Permanent Review Board in 2006.
- Fr. Van Hoorn was suspended from active ministry by Bishop Graves in 1979.
- Fr. Van Hoorn died in 2006.
- Review of Fr. Van Hoorn's file in 2019 showed further evidence of another allegation of sexual misconduct and abuse of a male minor.
- The evidence was presented to the Permanent Review Board in 2019 and the allegations were deemed credible.
- The following name is that of a Diocesan priest, incardinated in another diocese accused of sexual misconduct while serving in the Diocese of Alexandria:

#### Fr. Gilbert Gauthe

- Priest of the Diocese of Lafayette, Louisiana
- Allegations of sexual misconduct and abuse of male minors dating from the 1970s were brought before the Permanent Review Board in 2004.
- · Fr. Gauthe was tried and convicted for similar offenses in Lafayette.
- The allegations were presented to the Permanent Review Board in 2019 and the allegations were deemed credible.
- D: The following names are those of religious priests, living and deceased, accused of sexual misconduct with minors while serving in the Diocese of Alexandria:

#### Charles Dekeukelare, Fr. CICM

- A priest of the Congregation of the Immaculate Heart of Mary.
- Review of Fr. Dekeukelare's file in 2019 showed evidence of an allegation of sexual misconduct and abuse of a male minor dating back to 1982.
- Fr. Dekeukelare was removed from public ministry. He pled guilty to and was prosecuted for Indecent Behavior with a Juvenile in Avoyelles Parish in 1982.
- The evidence was present to the Permanent Review Board in 2019 and the allegations were deemed credible.

#### Fr. Norman Rogge, SJ

- A priest of the Society of Jesus.
- Review of Fr. Rogge's file in 2019 showed evidence of an allegation of sexual misconduct and abuse of a male minor dating back to 1985.
- Fr. Rogge was arrested on a charge of Sexual Battery of a male minor in Florida.
- He was sentenced in Florida on a charge of Lewd Conduct in the Presence of a Minor in 1985.
- Fr. Rogge died in 2009.
- The evidence was presented to the Permanent Review Board in 2019 and the allegations were deemed credible.

#### Fr. Louis Senesac, CSV

- A priest of the Clerics of Saint Viator.
- Review of Fr. Senesac's file in 2019 showed evidence of an allegation of sexual misconduct and abuse of a male minor dating back to 1945.
- Fr. Senesac was removed from active ministry in the diocese.
- Fr. Senesac died in 1966.
- The evidence was presented to the Permanent Review Board in 2019 and the allegation was deemed credible.

#### Fr. Antonio Valez- Lopez

- A priest of the Congregation of Capuchin Religious Tertiaries of Our Lady of Sorrows.
- An allegation of sexual misconduct and abuse of a female minor dating back to 2006 was brought to the attention of the Archdiocese of Baltimore in 2009 where the abuse took place.
- The Diocese of Alexandria was informed of the investigation by the Archdiocese of Baltimore in 2016 and Fr. Valez-Lopez was removed from public ministry in the Diocese of Alexandria.
- The Archdiocese of Baltimore initiated proceedings and Fr. Valez-Lopez's case was sent to the Congregation for the Doctrine of the Faith in Rome.

Beginning in August of 2018, a group of lay leaders and a group of our clergy have assisted me in a complete study of our records of all the clergy that have served in our parishes, missions, institutions and schools. This action has been done to offer the people of this diocese a complete record of those clerics that have been credibly accused of the sexual abuse of minors. The work has been a

painful but necessary examination of the past. It is only by shedding light on our past that we as the Church in central Louisiana can move forward in hope of healing and strength. Eight lay people, including three members of the Permanent Review Board and seven members of the clergy assisted me in reviewing 535 files of clergy who have served in the diocese since its establishment in 1853. This represents all existing records of clergy who have served in the diocese since its establishment to the date of this publication.

A careful examination of this publication will show that most of these clergy were deceased before any investigation of allegations against them could be made according to the standards implemented by the Charter for the Protection of Children and Young People (2002). What we see in examining the written records is that there was no standard response on the part of our past bishops and clergy to the allegations made. This publication of the names of the clerics listed above is not a declaration of their guilt. But, from an exhaustive review, the evidence of allegations brought against each cleric was deemed to be credible based on the materials examined. The Permanent Review Board of the Diocese of Alexandria in their study of each case unanimously agreed to the publication of these names.

To gain perspective on this evil chapter in the life of our diocese, it is important to look at a chronology of the credible accusations made against 27 out of

over 535 clerics who have served the diocese since its founding. These 27 cases represent roughly 5% of the number of clerics who have served in central Louisiana. The majority of the documented cases of abuse occurred in the 1950s, '60s and '70s:

1940 to 1949	One case
1950 to 1959	Four cases
1960 to 1969	Thirteen cases
1970 to 1979	Two cases
1980 to 1989	Five cases
1990 to 2002	One case

After the implementation of the 2002 Charter for the Protection of Children and Young People:

One case

Since the adoption of the Dallas Charter and the implementation of the VIRTUS program, along with greater vigilance in our formation programs, we have seen one new case where an allegation of abuse has been deemed credible by the Permanent Review Board. Still, one instance of abuse is one too many. It is my hope that by constant vigilance and awareness we may prevent this tragedy from ever happening again. We must never forget the damage that has been done to the victims, their families and to the whole Body of Christ which is the Church. While we live with the reality of evil, it is my hope that none of us will ever lose sight of the victory that has been won for us by Our Lord, Jesus Christ.

Trusting in his love for us, I, together with all my fellow priests, deacons, religious and coworkers in the diocese extend our heartfelt sorrow for all the pain and anguish caused to our children and youth

by this evil. Please know that I am ready to meet with any victim in this healing process.






## **Clergy assignments**

## **Ten Benefits of Natural Family Planning**

There are many benefits of using natural family planning in marriage, but let's start simple....

1. It's Healthy. There's lots of hype these days around allnatural, non-GMO, organic, unprocessed, preservative free, grain free, dairy free, no added sugar, and additional choices for our diet. But have we thought about what we may be putting into our bodies for family planning purposes? Natural family planning (NFP) passes all of the above requirements and more. It's medication-free! Which means there are absolutely no unwanted or troublesome side effects from its use.

**2. It's Green.** It's extremely friendly to the environment since it does not require oil or any kind of pollution for its production or shipment. There are no artificial



hormones that end up in our tap water and environment from its use.

**3. It's Economical.** After the one-time cost for the main class (around \$135 for the book and supplies), it's virtually free for the rest of your life. There is a small fee for supplemental classes, such as the Postpartum (fertility after childbirth) and Pre-menopause classes. But, NFP does not impose a monthly cost. That's a lot of savings over a lifetime!

**4. Awareness to Medical Issues.** Using natural family planning may bring attention to medical issues

that a wife may not have known she had. When a woman's cycle is unaltered by outside synthetic hormonal influence, and there is a certain irregularity or problem present, it could mean there is a medical concern that needs to be addressed, progesterone or thyroid deficiency for example.

**5. It's Effective.** The Sympto-Thermal Method of NFP has several different rules to choose from for the different phases of a woman's cycle. The married couple adheres to the guidelines for physical intimacy when wanting to space pregnancies.

The most common rule to use for the longest infertile phase has a method-effectiveness rate of 99.6%. All of NFP science is based on decades (almost a century, really) of collective research and numerous scientific studies, particularly those of Dr. Petra Frank-Hermann and Dr. Josef Roetzer.

**6. Growth in Virtues.** Using natural family planning to space children in marriage compels practice in self-control, self-discipline, patience, purity, obedience to the Church in her insightful teachings, respect for God, and respect for your spouse to name a few. All of these being virtues we should strive for in our Christian life as well as our use of NFP.

7. Shared Commitment. The accountability of tracking fertility signs is meant to be shared by both spouses, not just one or the other. The husband is asked to hand his wife the thermometer in the morning to take her basal (waking) body temperature, which is one of the fertility signs. The wife then makes fertility observations throughout the day.

8. It's Versatile. The strength (that I love!) of the Sympto-

Thermal Method of natural family planning is its incorporation of three different fertility signs. That way, when one sign is possibly affected by sickness or stress, you can rely on the other sign(s) for accurate interpretation of the phases.

**9. Witness God's Design.** When a married couple uses NFP, they can clearly see the intricate and beautiful way that God created their bodies and their gift of fertility.

10. Practice of Putting God First. When we choose to honor God and His design of our bodies first and foremost with our fertility, the practice of putting Him first in other areas of marriage more easily follows. When we elect the Lord as the center of planning our family, it innately flows to put Him first when it comes to communication, finances, education, parenting, work, etc.

Is using NFP always easy? No, not always. But I can't think of a single thing the Church calls us to do specifically because "it's easy."

My husband, Michael, and I are certified teachers through The Couple to Couple League International and teach the Sympto-Thermal Method, which uses three different fertility signs to identify the natural fertile and infertile phases of a woman's cycle. The Couple to Couple League is a Catholic non-profit organization established in 1971, and is the largest provider of NFP instruction in the United States.







## Chat 2.0 - Marriage: It's Worth Talking About

The months of planning leading to the perfect wedding can become so all-encompassing, that it consumes a couples' conversations. "Is that on your list or mine?" "Do we really have to invite Uncle Gerald?" "Why is your mom being so difficult?"

It's easy to get distracted from what the engagement period is really for: to continue to learn about your future spouse in a more intimate way; to continue to grow your relationship with each other in love and understanding; to continue to build a foundation for a lasting marriage. Don't be satisfied with chatting about surface conversations. Many of the deeper conversations can be difficult and awkward, or they can be eye-opening and fun. Approach serious conversations with joy, knowing that you are becoming closer to the person with whom you will spend the rest of your life.

We have taught our program "Strong Foundations: A Marriage Preparation Program for Catholic Couples" for several years. Through our own marriages and through our years of research, we have learned that when couples want to build a strong foundation for marriage, they address the following topics before their wedding:

#### 1. Faith and Spirituality

If you are seeking a sacramental marriage in the Church, share with each other why this this important to you. Take time to learn what you believe and how you live out your beliefs. By taking time to share your expectations for living your faith within your marriage, you can deepen your relationship.

Most people have heard the adage, "A family who prays together, stays together." (—Fr. Patrick Peyton). Consider praying together, if you aren't already doing so. If you need a simple way to begin, try blessing your meals or saying an Our Father before a road trip. Simple starts can lead to an amazing spiritual connection.

#### 2. Conflict Management

Every couples disagrees at some point. What kind of



"fighter" are you? Do you shut down? Lash out? Run away? Say things you regret later? Stay uber rational and cool?

We have worked with couples react to conflict in every way imaginable. Ultimately, you can learn to recognize your own triggers and those of your fiancé. You can also learn how you and your future spouse react to conflict. This knowledge can help you disagree in a way that is less hurtful and more constructive.

#### 3. Careers

We spend more time at work than with our spouses. Try to stay connected to each other's work. Be open about what happens at your job. Do you love your job? Does your career cause conflict in your marriage? Does your career fit your long-term needs and wants for your marriage? Will one of you stay home if and when children come along? Is there a chance of relocation for your job?

When you keep each other involved in the story of your day, you stay connected. Don't get us wrong, there are some jobs that bore us to tears. However, boredom is irrelevant. It is the act of listening and being available that builds your relationship.

#### 4. Finances

Finances are often cited as the cause of most divorces. However, it isn't the finances, but the lack of discussion about finances that is the culprit in most divorces. Get on the same page with your finances. Share your accounts whenever possible, or, at the very least, share your account passwords. It is too easy to hide things when finances are not transparent in a marriage.

Do you have debt you are bringing into the marriage? Do you have savings? Do you have issues with over-spending? Do you have an inheritance? What does your budget look like? At what dollar amount would you need to consult your spouse before making a purchase?

At one of our marriage prep workshops, one couple stated they would have to consult their spouse for any purchase over \$50. Another couple stated they would need to consult their spouse for any purchase over \$1000. These couples had different incomes and lifestyles, so they picked a number that worked for them. Neither amount is right or wrong...they are perfect because they are agreed upon.

#### **5. Intimacy / Cohabitation**

When we discuss intimacy with couples in our workshops, we ask them to write on a card, "How many times per week do you plan to have sex?" Then we ask them to show each other their cards. Inevitably, there's a lot of laughter in response to this question. But the question is a valid one...and it speaks to the expectations that are often unspoken in marriage.

When it comes to cohabitation, many couples don't realize that living together before marriage is problem until their first meeting with a priest. We are called through our Christian faith to live chastely until marriage. That means no sex. When couples live together, they are blatantly ignoring the standards to which Christ is calling them.

We offer this challenge in our workshops: What prevents

you from living apart from now until your wedding? Statistics show that those who live together before marriage are more likely to divorce. Give your relationship a chance to grow through abstinence and purposeful interaction.

#### 6. Family of Origin

Who raised you? That's your family of origin. The people who raised you affect your interactions with your spouse. Notice, we didn't say you will have a marriage exactly like your family of origin. They will affect your marriage, not pre-determine it.

Sometimes the marriages modeled before you were amazing, and you hope that your marriage is equally as strong as those you have witnessed. Often, though, couples are from backgrounds of divorce, addiction, infidelity, apostacy, apathy, etc. You many not want to emulate any part of the marriages you have experienced.

Be smart about what your marriage should look like. Implement the best parts of the marriages you have seen; seek a mentor couple; discuss your family's not-so-hot interactions in marriage and chat about how you can avoid the same in your marriage. Whatever you do, talk about it. Be real with what you were exposed to in your family of origin's marital interactions and seek unity on how to implement or exclude those interactions from your own marriage.





#### 7. Children

Children are the greatest blessing and greatest challenge of marriage. Parenting is difficult, even when both parents are on the same page. If you disagree greatly about parenting styles, it is even more challenging.

All couples are called to procreate, if they are able. A marriage isn't valid if one or both of you decide you don't want to have kids. This is a chat that needs to happen when you meet with your priest.

Your conversations about children can't just be about your favorite baby names and the color you want your future nursery. Talk about the potential challenges inherent in child-bearing and child-rearing. How will you handle it if one of you is infertile? If you have an unplanned pregnancy in your marriage? If you have a child with special needs? How will you handle blending your families if you have children from a previous relationship?

#### 8. Commitment

We have a friend who once said of her marriage, "Somedays we live on love, most days we live on commitment." She is in a happy marriage, so what does she mean? Even in the happiest marriages, things pop up that require couples to dig deep and work together to get through their troubled times. While "love" may run deep, sometimes "like" feels like a shallow puddle.

What will hold you to your vows when everything in you wants to throw up your hands in resignation? What will push you to seek help when things get difficult? Your commitment to God, to your vows, to your spouse, to your family.

As you approach the altar, remember to tackle sensitive topics as often as task lists. Remember, you aren't seeking complete agreement on every little topic; what you are seeking is agreement on the biggest topics

Be vigilant: No one plans to end up at the divorce attorney's office. No couple says, "I hope this will be a fun first marriage!" Couples approach the altar with "forever" in mind, yet 50% of marriages end in divorce. This statistic doesn't have be you.

Create your forever today. Be open, honest, and brave when chatting about the controversial topics of marriage. Build your relationship on the strong foundation of Christ and common values. Be real...so that your marriage is as amazing as your wedding.



## As World Youth Day closes, pope prompts volunteers to keep serving

PANAMA CITY (CNS) --Just before leaving the physical and human warmth of Panama Jan. 27, Pope Francis stopped to thank the thousands of official volunteers, young and old, gathered at the capital city's Rommel Fernandez Stadium to tell them that they had just participated in an event similar to one that took place early in Christianity.

In their case, they didn't just multiply food, he said.

"You could have easily chosen to do other things, but you wanted to be involved, to give your best to making possible the miracle of the multiplication, not only of loaves, but also hope," he said, telling the volunteers to go out into the world and make that attitude contagious. "We need to multiply that hope."

Volunteers at Panama's World Youth Day showed it was possible to renounce one's interests in favor of others, the pope said.

On stage, before the pope spoke, Bartosz Placak of Poland offered his testimony in Spanish to those gathered at the stadium and said that while volunteering for World Youth Day in Panama, he had experienced a taste of what living in the early Christian communities must have been like: sharing food, homes, anything

other people needed.

"In sharing, you create a small community and we return to the times of the first Christians ... we follow their example," he said.

Panamanian volunteer Stella Maris del Carmen told the story of how she had planned to attend the previous World Youth Day, an event she'd longed to attend since she was a child. She had saved enough money to go to Poland in 2016 and then her grandparents died. She canceled her plans and used the money she had saved to tend to her family.

The pope said he was touched by her story. By renouncing the trip for the family, "you honored

your roots," the pope told her. "That's what makes you a woman, an adult." But then consider what happened because of that sacrifice, he said.

"The Lord had the gift of (World Youth Day) waiting for you in your homeland," he said. "The Lord likes to play those tricks. That's how God is."

What a person gives to others "the Lord returns" many times over, he said. And the world needs more such examples of surrender and love to provide a "balm in the lives of others," he said.

Panamanians certainly had heeded that counsel long before the event.

World Youth Day 2019 in Panama may not have been the largest, in terms of attendance. Event officials say some 113,000 registered as pilgrims to attend various events -- though it was obvious that many more who did not register filled up the venues.

What the event in Panama may -- or may not -- have lacked

in numbers, it made up for in its treatment of young pilgrims. Priests, bishops, women religious and thousands of volunteers. young and old, officially and unofficially, seemed to devote more quality time to participants than in the past, said pilgrims such as Francisco Apenu Cofie of

"It was more intimate," said Cofie, who attended World Youth Day in Poland and Brazil. Panama had a special touch, he said.

"I have received more than what I expected, and this is the mystery of the divine gifts. I am happy," he said.

Though the pope spent time with the volunteers who attended the ceremony at the stadium, there were thousands of other unofficial helpers, such as those who offered water to pilgrims passing through their neighborhoods, who sprayed them with water hoses to cool them off, and offered use of their facilities or couches to rest, but who did not attend the event.

"Thank you all, because in these days you have been attentive to even the smallest details, however ordinary and apparently like offering insignificant, someone a glass of water," the pope said to volunteers at the ceremony.

In giving to others, God blesses, the pope said,

"You have had a more lively and real experience of faith. You have experienced the strength born of prayer and a new and different kind of joy, the fruit of working side by side even with people you did not know," he said.

There were many moments when volunteers did not understand the pilgrims or vice versa but, by and large, most did not let that stop them from attempting to communicate with one another.

Panamanians outwardly celebrated pilgrims from various visiting countries, spontaneously shouting out the name of the nation as they spotted them carrying their respective flags on the streets of their city.

One of the gifts of Panama's World Youth Day, El Paso Bishop Mark J. Seitz told Catholic News Service, is that at a time when some in the world are embracing nationalism, the international Catholic festival for youth, in which 156 countries participated, delivered the opposite message. People from different countries, who spoke different languages and had different customs and practices, managed to unite around faith and serving others.

"World Youth Day says, We're one family of humanity," Bishop Seitz said. "Separating ourselves from others does not make us secure."
